Competition Rules and Information:

1. Competition will be conducted in accordance with SOBHD and FUSTA regulations
2. First to enter last to dance rule applies
3. Highland and National points will be combined to determine aggregate trophy winner
4. Judges decision is final
5. All age groups will be determined at close of entry
6. All groups will receive medals and cash prizes will be awarded to premier dancers
7. An aggregate trophy will be awarded in each class, except primary, as long as there are at least three dancers in the age group
8. Current year FUSTA card required to compete
9. Entries received after June 27, 2018 will be considered late and a \$10.00 late fee will be added. **No entries will be accepted after July 6, 2018.**
10. Awards will be given following each session

**Primary:** Fling 4 step (100) Sword 2&1(101) 16 Pas de Basque (102) Pas de Basque and High cuts (103)

**Beginner:** Fling 4 step (200) Sword 2&1 (201) Seann Triubhas 3&1 (202) Lilt 4 step (203)

**Novice:** Fling 4 step (300) Sword 2&1 (301) Seann Triubhas 3&1 (302) Flora 4 step (303)

**Intermediate:** Fling 4 step (400) Seann Triubhas 3&1 (401) Flora 4 step (402) Lilt 4 step (403)

**Premier:** Fling 6 step (500) Seann Triubhas 4&2 (501) Flora 4 step (502) Earl of Errol 4 step (503)

Entry fee is \$7.00 per dance. (The \$2.00 FUSTA fee is included in the entry)  
Current 2018 FUSTA Card number must be presented when pre-registering.  
Entries received after June 27, 2018 will be considered late and a \$10.00 late fee will be added. **No entries will be accepted after July 6, 2018.**
